When in Rome: Examining faith branding in contemporary higher education

Perceptions of higher education institutions serve as a “principal aspect in building the brand image of the respective institution” (Lee, Miloch, Kraft, & Tatum, 2008, p.178), and as such, schools are to be cognizant of the messages that they convey and how stakeholders view them. This is particularly important for Christian higher education institutions as they seek to convey compelling messages that resonate with desired audiences while testifying to the mission and values of the institution (i.e., conveying messages of Christian ethos and adherence to tenants of Christian faith). Using case study methodology, branding considerations at two Christian-based higher education institutions will be presented through detailing the application and integration of Christian faith in higher education. The profiled institutions were strategically selected as they are located in the same geographic area in the Southeastern United States, while still demonstrating points of distinction associated with the respective academic brands—including the application of academic program marketing and intercollegiate branding considerations. Points of distinction include messages conveyed through brand communication strategies pertaining to institutional identification and Christian identification. Such points of comparison are significant as the schools operate in a competitive market as they vie for students, resources, and reputation.

Faith-based institutions, including their relevant academic and intercollegiate athletic programs, can benefit from strategic branding and image enhancement practices and those tasked with branding implementation need to be mindful of the various challenges that exist. While institutions are able to implement practices reflecting sound brand management implementation, some are hampered by ineffective branding initiatives that lack congruence and uniformity generate complications that hinder institutional marketing efforts and differentiation strategies while affecting the overall strategic vision of the school (DiGisi, 2004; Lee & McRee, 2019). Such principles will be examined through an open forum for discourse for faith-based institutional considerations and strategies.

Success or failure? A Look at a private-Christian university's move from the NAIA to NCAA Division II

From the early 2000's to present, multiple private-Christian universities have chosen to move from the National Association of Intercollegiate Athletics (NAIA) to the National Collegiate Athletic Association (NCAA). Many of those schools have chosen NCAA Division II based on size and fit. Union University began the move in 2011-2012 and were approved for membership by the NCAA D2 membership committee in the summer of 2014. Union became members of the GulfSouth Conference, composed of schools from Tennessee, Mississippi, Alabama, Georgia, and Florida. The researchers for this presentation will look at the athletic performance of the athletic programs at Union University in the 5 years (2006-2011) prior to moving and compare that to the athletic performance of the same programs during the first 5 years (2014-2019) of NCAA membership. They will also report statistics related to enrollment, budget, and coaching turnover.

Examining the training of volunteer youth sport coaches in church-based youth sport leagues

Church-based youth sports ministries offer youth sports to the community with the mission to share a faith message. The purpose of this study was to understand faith-based youth sports leaders' volunteer coach training methods and attitudes. Positive youth development (PYD) is intentionally using sports skills and lessons to teach productive life skills. Research demonstrates the importance of intentional coach training to promote PYD. An online survey was created using QuestionPro and received via email by 291 sports ministers in the United States. The survey internet link was available for three weeks and 32 sports ministers completed the survey resulting in an 11% response rate. Descriptive statistics was used to analyze the results using frequencies and percentages. Qualitative research was used on an open-ended question to find common themes in challenges sports ministers face in coach training. Results demonstrate the majority of sports ministers intentionally train volunteer youth sport coaches by requiring training with follow-up accountability. Results are further demonstrated in the amount of time each coach spends in formal and informal training. The content taught at coach training frequently reflects professional knowledge/skills and intrapersonal knowledge/skills. However, when comparing to previous research, more content should focus on interpersonal knowledge/skills, legal responsibilities, and risk management. Coach training is primarily taught with a hybrid of classroom and online formats. A mixture of content resources is used from publishers and churches that create their own materials.

Take them to church: Sport branding and faith integration**Jason W. Lee***University of North Florida***Laci McRee***East Texas Baptist University*

Through the use of parallelism, the application of components of Christian faith and sport branding will be presented in a conceptual form that illustrates key academic components associated with sport marketing pedagogy and identifying strategies for faith integration. Utilizing the rhetorical device of parallelism, the examination of elements of the Christian worldview as applied to the academic context of sport marketing, and more specifically the key concepts of sport branding, session attendees will be presented a guide for appreciation, understanding, and application.

A model will be presented demonstrating how Christian educators, students, and practitioners can illustrate and implement impactful Christian practices through the study and application of sport marketing and branding principles. By presenting the conceptual brand communication model that examines branding “tent poles” consisting of *Identity, Image, Ethos, Stewardship, Evangelism, and Transformation*. Each of these tent poles will be detailed in a manner that juxtaposes the broader construct defining the commonality associated with the Christian worldview through the alliteration of the notion of themes illuminate in the bible. In this sense, the model will be presented in a format that foundational knowledge of sport branding application when applied to a Christian context, individuals can resonate with connection points based on foundational Christian knowledge and understanding. Application strategies will be provided illustrating how the provided framework can be implemented for faith-based universities, churches, church-based groups, church-based sports programs, and parachurch organizations. A specific application involving defining one's "personal brand" and incorporating it with integration to the "Great Commission" will be detailed in the session. Additionally, this professional session is to provide an open forum for the discussion of relevant practices, strategies, and future considerations associated with this conceptualization.

 - a. Meeting began at approximately 3:37 p.m. (EDT) with introduction of attendees as well as the current CSKLS Board of Directors.
 - b. Wayne recognized first-time and multi-year attendees.
 - c. Attendees were encouraged to join the CSKLS listserv.
- II. Administrative items
 - a. Introduction of Board of Directors
 - I. **Wayne** (President) formally introduced the current CSKLS Board of Directors in attendance including **Andy Meyer** (President-Elect), **Steve Waller** (Past-President), **Matthew Ruiz** (Treasurer), **Landon Huffman** (Secretary), **Monica O'Rourke** (Member At-Large), **Lori Peters** (Member At-Large), **Matt Hoven** (Member At-Large), and **Jordan Schools** (Student Member At-Large).
 - b. CSKLS 2018 Annual Business Meeting Minutes and Treasurer's Report
 - I. Minutes as submitted by **Andy Meyer** were a motion; **Steve Waller** seconded the motion; no discussion from attendees and minutes were approved.
 - II. **Matthew Ruiz** has assumed the role of Treasurer and manages the day-to-day custodial functions and banking responsibilities.
 - III. The formal Treasurer's report is not yet available (no vote occurred), but the checking account has a balance of approximately \$11,000 and the Gordon-Dahl Fund has approximately \$8,500. These amounts are representative of a typical CSKLS' fiscal year. The CSKLS articles of incorporation will remain in Michigan.
 - c. Report on the Activities of the BOD during 2018-2019
 - I. **Wayne** presented highlights of the past year's BOD activities including new branding initiatives (including a new logo), strategic discussions of the vision of CSKLS for the next 30 years given the transition of leadership and membership, creating a Communication Team which launched social media initiatives and a newsletter, increased mentorship opportunities (more faculty members are needed to serve as mentors!), and migrated the J-CSKLS platform to the University of Tennessee's bepress infrastructure (<https://trace.tennessee.edu/jcskls/>).

2. Presenter(s) information (name, title, institution, address, email, phone)
3. Abstract (not to exceed 300 words)
4. Christian Perspective* (not to exceed 100 words; explains how the Christian worldview and faith integration inform the presentation)
2. Learning Outcomes (3 succinctly written)

Empirical presentations are highly encouraged. **If your presentation is strictly empirical please complete proposal elements 1, 2, 3, & 5.*

III. Submission of Proposals

IV. Acceptance of Presentations

Only complete proposals will be eligible to be reviewed by the Program Committee through a blind, rolling review. Notification of acceptance or rejection will be made via email by no later than **March 5, 2021** for non-student proposals. Selections will be made according to:

1. Appropriateness of content for the desired session.
2. Demonstrated organization of material and learning outcomes.

Presentations which were accepted for 2020 but not delivered are automatically rolled over to 2021.
